- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Better Community Po-
- 5 licing Recognition Act".

7	"(a) Definitions.—In this section:
8	"(1) Better community policing award.—
9	The term 'Better Community Policing Award' means
10	an award authorized under subsection (b).

12	The term 'eligible law enforcement officer' means a
13	career law enforcement officer who is—
14	"(A) employed by a law enforcement agen-
15	cy receiving funding from a grant under section

1	"(b) Awards Authorized.—The Attorney General
2	may distribute cash awards to eligible law enforcement of-
3	ficers who exemplify best practices or significant innova-
4	tion to—
5	"(1) reduce the excessive use of force; or
6	"(2) improve community policing.
7	"(c) Criteria.—Not later than 90 days after the
8	date of enactment of this section, the Attorney General
9	shall establish—
10	"(1) the process by which a law enforcement
11	agency or the attorney general of a State may nomi-
12	nate an eligible law enforcement officer for a Better
13	Community Policing Award;
14	"(2) the criteria for the selection of recipients
15	of a Better Community Policing Award; and
16	"(3) the maximum amount of a Better Commu-

18	"(d) Report.—Not later than 1 year after the date
19	of enactment of this section, and annually thereafter, the

3	"(3) a geographical breakdown of the location
4	of the recipients of a Better Community Policing

6	"(4) information relating to the size of each law
7	enforcement agency that—
8	"(A) nominated a law enforcement officer
9	for a Better Community Policing Award; or
10	"(B) employed a recipient of a Better
11	Community Policing Award.
12	"(e) Authorization of Appropriations.—There
13	are authorized to be appropriated to carry out this section
14	\$5.000,000 for each of fiscal years 2021 though 2025.".
